Please read carefully AND initial ALL lines below

_____ I authorize the above credit card to be used as a damage/security deposit for each snowmobile I rent. I am fully responsible for the snowmobile(s) and will pay for all broken, cracked, bent, ripped and missing parts off my snowmobile(s) if damaged while in my possession, including the drive belt. I will inspect my snowmobile(s) prior to riding it and note any existing damage on the "Renters Checklist" during the pre-ride inspection. I will pay for any damaged, lost or blood contaminated equipment included with my rental including suits, boots and helmets. I agree pay for all damages today.

_____ If anyone in my party or I need to be rescued, towed, or assisted if STUCK, for non-mechanical reasons, there will be a \$100 minimum rescue fee. This fee includes 1 rescuer for 1 hour. Each additional hour and/or rescuer will be billed \$100 per hour.

_____ If my snowmobile(s) is wrecked/damaged I understand there is a minimum ½ hour labor charged to all damages. Labor rate is \$100 per hour. The labor rate is calculated using the Ski-Doo Flat Rate Manual and multiplied by 1.3. I agree to pay the manufactures suggested retail price (MSRP) for all parts.

_____ If my snowmobile is wrecked/damaged while in my possession and determined by Spirit Lake Lodge & Snowmobile Rentals (SLL&SR) staff to be totaled and/or beyond repair, I agree to pay the full retail price of the snowmobile plus tax.

_____ If my snowmobile sustains substantial damage while in my possession, and is unable to be fixed today. I understand I will be charged for "Loss of Rental" (not to exceed 14 days). Rates are provided on the brochure.

_____ I agree that I will stay on the marked trails and follow the recommended route. SNOWMOBLING ON LAKES IS NOT PERMITTED.

_____ I certify that I am not under the influence of any alcohol or drugs, including marijuana. All alcohol and drug incidents will be turned over to the Grand County Sheriff.

_____ I understand that SLL&SR does NOT provide any refund if snowmobile(s) are returned early or due to adverse weather.

_____ I understand that there are additional charges if the snowmobile(s) are returned after their scheduled return time. Departure and return times are noted on the "Snowmobile Checkout Form". It is my responsibility to know what time I return.

_____ I voluntarily agree to assume all known and unknown risks as to the use of the rental equipment which could result in injury or death and damage to property of myself or others. I agree to wear a DOT certified HELMET and proper eye protection at all times.
